Administrative Reports

Superintendent and 9-12 Principal Report – Superintendent Henrich reported that the security assessment report has been received. The most immediate needs are an improved phone system for both buildings as well as improved lighting in the back of the building by the ball fields and security cameras in back hall ways. Henrich and Brian Shifflett will be meeting with Pelling Asphalt to sew what patchwork will need to be done in the summer. Lights also need to be replaced in the weight room. The 800 series of the board policy will need to be reviewed. This can be done in late March and approved in April or May.

Pre-6 Principal/Curriculum Report – Principal Milledge reported that the "Books Are Fun" book blast is having great participation. This program tries to build home libraries for students. Milledge has been working with the Keota Eagle Advocates on grant writing for the elementary playground project. Elementary staff have also volunteered to be a part of the committee. The FAST CBMr data has been reviewed and as a school 60.75% of Keota students are proficient on the CBMr FAST assessment. Finally, discussion with elementary staff have begun about plans for next year as well as the PK/Kindergarten plans.

Activities Director Report – Winter sports have concluded and spring sports are beginning. There are 15 boys and 10 girls out for HS track and 1 girl and 7 boys out for golf.

Business Manager Report –Bank statements were balanced and March payroll was completed. AP invoices were paid and board packets assembled. Board financials were prepared.
